



# The GSA Professional Services Schedule (PSS)

The GSA PSS (formerly known as 00CORP) is an indefinite delivery/indefinite quantity (IDIQ) multiple award schedule, providing direct access to simple or complex fixed-price or labor-hour pro services.

## WHY WOULD YOU USE PSS?

The PSS allows agencies to:

- Use simplified acquisition procedures to issue a Request for Quotation (RFQ) using either your agency's solicitation system, GSA's eBuy solicitation system, or issue an RFQ directly to contractors using your agency's procedures.
- Allow unique Contractor Team Arrangements to bring a wide variety of industry partners to the negotiating table.
- Customize terms and conditions in task orders or through Blanket Purchase Agreements to meet specific requirements.
- FAR terms and conditions are incorporated.

# GSA PSS

## GSA ORDERING PROCEDURES

Ordering procedures are simple and follow the FAR (8.405-2)

1. Prepare SOW and establish evaluation criteria
2. Receive three quotes
3. Limited Sources Justification if applicable
4. Seek price reduction
5. Best value determination
6. Overall price reasonableness determination
7. May not place orders orally

### SIN 541380 System Design, Engineering, Integration

System Design, Engineering, and Integration Services required under this SIN involve the translation of a system (or subsystem, program, project, activity) concept into a preliminary and detailed design (engineering plans and specifications), performing risk identification/analysis, mitigation, traceability, and then integrating the various components to produce a working prototype or model of the system.

### SIN 541420 Test and Evaluation

Test and Evaluation Services required under this SIN involve the application of various techniques demonstrating that a system (subsystem, program, project, or activity) performs in accordance with the objectives outlined in the original design.
